- the effects of weather which is variable and may change at any time.
- faulty equipment or Attraction facilities; and
- the behaviour of other participants, and
- Covid-19

and that such risks are potentially dangerous and could result in serious injury, including permanent disability or death.

As a participant of the activities and/or by entering the Attraction, I accept those risks which a prudent person is or should be aware and understand the requirement to always exercise good judgement and act in a responsible manner whilst undertaking the activities at the Attraction.

I agree to explain and ensure any participant for whom I am responsible and who is listed in this form is aware of the requirements for attending and participating at the Attraction. I take full responsibility for the behaviour and conduct of all persons under my supervision who are listed in this form.

### **Indemnity and hold harmless**

I hereby fully indemnify and hold harmless Inflatable Fun Park, its officers, directors, employees, agents and contractors from and against all claims, suits, demands, expenses and costs of whatsoever nature which I or any other person has in respect of any death, injury, loss or damage sustained by me in connection with the Attraction including whilst undertaking any activities at the Attraction notwithstanding that such death, injury, loss or damage is due directly or indirectly from any negligent act or omission, default, breach of duty, breach of statutory duty by or on behalf of Inflatable Fun Park, its officers, employees, agents or contractors.

This indemnity and hold harmless extends and is expressly intended to cover any claim above by or on behalf of a participant listed in this form against Inflatable Fun Park or a third party.

### **Waiver of Rights and Release from Liability**

To the extent permitted by law, I voluntarily waive my right to bring any legal proceedings or claims against Inflatable Fun Park and voluntarily release and forever discharge Inflatable Fun Park its officers, directors, employees, agents and contractors from liability for any claims connected with or arising from my participation in the activities of the Attraction, including where caused by any person's negligence or wilful misconduct, including:

- for any loss, damage or injury;
- for any incidental, direct, indirect, special, consequential, or economic loss or damage (including any distress, inconvenience, or anxiety); and
- for any loss of opportunities, exemplary or punitive damages whether to person or to property

arising out of the holding of the Big Bounce Australia or my attendance or participation at the Attraction and whether arising from default, negligence, misconduct or otherwise by Inflatable Fun Park, its management and staff.
